The duties and responsibilities of the mentor are described in the ACDS mentor job description and the ACDS policy and procedure manual. Mentors are expected to follow all responsibilities within those documents, which include the following:

- Meet with mentee a minimum of two hours a month, for a minimum of 12 hours a semester
- Submit all required documentation on or before deadline date
- Discuss topics and concerns relevant to the mentee and ACDS curriculum to further understanding
- Conduct behavior in a professional and ethical manner in adherence to the NAEYC Code of Ethical Conduct

II. Compensation

The ACDS mentor shall be compensated at the sum of \$200.00 for a minimum of 12 contact hours per six-month period and an additional \$10.00 per monthly visit. Fewer than 12 contact hours shall be prorated. In addition, mentors are eligible for mileage reimbursement if contact visits are made in-person. Mileage will be reimbursed at the current rate approved by the state of WV. If all stipulations of this service agreement are not fully met by the ACDS Certified Mentor, the ACDS Statewide Project Manager has the right to terminate this service agreement. Deadlines for submission of all required documents are January 15 for the fall semester and June 15 for the spring semester. Submission of required documentation after the deadline dates will likely result in nonpayment.
